### State governmental affairs

Engaging in strategic partnerships and coalitions, HANYS advances proactive policies that strengthen healthcare delivery and support the needs of hospitals, health systems and continuing care providers across New York.

### Federal governmental affairs

With an office based in Washington, D.C., HANYS' federal governmental affairs team advocates to protect and strengthen Medicare, Medicaid and other key programs that impact New York's healthcare providers. We work with national partners like the American Hospital Association and Association of American Medical Colleges, and we leverage strong relationships with New York's congressional delegation to advance policies that support our members and the communities they serve.
