### Economic and Community Benefits

#### Economic activity \$1,129,000,000

The economic activity generated by hospitals through jobs and the purchase of goods and services makes up 9.6% of the state's entire gross domestic product.<sup>[1]</sup>

# Payroll expenditures \$341,000,000

New York hospitals' #1 investment is in their people, including direct salary and benefits to their employees.<sup>[4]</sup>



#### Outpatients provided care 677,000

Adhering to their charitable mission, hospitals cover the cost of care

provided to people in need; subsidize care and services to low-income,

Hospitals serve patients in their communities 24/7, 365 days a year.<sup>[4]</sup>

#### Patients covered by Medicare and Medicaid

In this district, Medicare and Medicaid patients make up:

- 70% of all people admitted to hospitals
- 71% of all outpatients provided care

**60%** of hospital patient service revenue in this district comes from Medicare and Medicaid. This is a result of the large volume of services being reimbursed by Medicare and Medicaid, which do not cover the cost of care, driving significant underpayment from these public insurance programs.<sup>[4]</sup>

## Jobs generated 5,700

Hospitals and health systems are often the largest employers in communities, generate many more jobs and are top 10 private sector employers in every region of New York.<sup>[2]</sup>
